

## Privacy Statement of EZ Factory B.V.

Through its service [www.ezfactory.nl](http://www.ezfactory.nl) will process privacy-sensitive or personal data. EZ Factory B.V. values the privacy of its customers and observes due care in processing and protecting personal data.

During the processing we stick to the requirements of the applicable data protection legislation. This means we:

Our website stores and retrieves information on your browser using cookies. Cookies have a variety of functions. ### **Google Analytics**

We use Google Analytics to track visitors on our website and to get reports about how visitors use the website. We accepted the data processing agreement from Google. We don't allow Google to use information obtained by Analytics for other Google services, and we anonymize the IP-addresses.

We take security measures to reduce misuse of and unauthorized access to personal data.
